JOURNAL ENTRY

NOW on this 4th day of November, 2008, this matter comes on for hearing on Respondent's Motion for an Unsupervised Weekend Trip to Attend Memorial Services for Respondent's mother. The motion contemplates an unsupervised trip to Great Bend to attend a family memorial.

Petitioner appears in person and with counsel, Donald R. Hoffman. Respondent appears in person, pro se.

The Court recites the text of the motion and inquires of the Respondent if she has further comments or evidence in support of her motion. Respondent advises that she does not.

Petitioner presents argument suggesting that Petitioner has volunteered to take the minor child to the family gathering in Great Bend and provide transportation, thus, eliminating the need for unsupervised parenting time.

THEREUPON, the Court announces that it is in receipt of a letter from Jill Dykes, Guardian Ad Litem, (made part of the record, -see attachment) which is circulated to the parties. Thereafter, further argument is heard.

The Court announces its decision as follows:


1. Respondent's motion is denied to the extent that the child would be in the unsupervised custody of Respondent for the memorial services in Great Bend;
2. The Court authorizes Petitioner (father) to accompany the child to the memorial allowing her to participate in the services.

The Court notes, for the record, Respondent's various objections to relating the taking of testimony of an unspecified witness.
